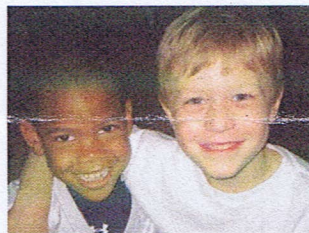
Dear Jack:
